3. Participation is open to all persons (children and adults) residing in the Greater Region (Grand Duchy of Luxembourg, Lorraine, Wallonia, Rhineland-Palatinate, Saarland). In case of doubt, the participant must provide proof of residence.
4. Only one participation per person is allowed.
5. UCVL staff members and their family members are not allowed to participate.
6. Participation will take place via a claw machine, accessible to everyone. Each participant has a chance to grab a prize among the gifts on offer. Prizes will be awarded according to their type and value, subject to availability. Even if the claw attempt fails, a small consolation prize will be offered thanks to our partners (subject to stock). Prizes won are neither exchangeable, refundable, nor convertible into cash.
7. Participation in the contest does not involve any purchase obligation for the participant.

## **Art. 2 Refusal of participation**

UCVL may refuse registration without providing a reason. There is no inherent right to participate. UCVL reserves the right to exclude participants already accepted at any time.
